This season we had over 400 nippers join Mets. A very big thank you to everyone who spent so much of their time in managing, organising, training, water safety and keeping all these children safe during the many different nipper activities and their attendance at surf carnivals.

CLUB CAPTAIN REPORT



Congratulations to all of our Active Members who contributed to making this season another successful and safe one for everyone who visited Kings Beach. For the record, we were visited by more than 103,000 people during our patrols throughout the season. Apparently 30,000 or so of these people decided to go for a swim between our flags. (Special mention goes to those keeping count too!) Together we responded to 49 incidents and performed 34 rescues. More about these shortly.

From a time perspective, we had 232 active members cover the beach for our 794 allocated hours across the season, and collectively we patrolled for 9,941 hours. This means that we averaged nearly 13 members on the beach for the entirety of our patrol times. I think this is a sign of a volunteer club with a fantastic team spirit from a wonderful group of community minded members. We are fortunate to have some members who consistently contribute an extraordinary level of their time. This season we had 6 members who patrolled for 100 hours and 84 members gave more than 50 hours. On behalf of the club, I thank you all for your contribution.

Patrol hours don't tell the whole story however, and most of our members made additional contributions in many different ways on top of their patrol hours. Congratulations especially to all members, both new and existing, who invested time and gained new awards during the season. This is vital to the evolution of each Patrol Team and to our Club as a whole. The confidence that comes with developing new skills also shows a commitment to growth and inspires other members to pursue their own development.



CLUB CAPTAIN REPORT CONT.

It's fair to say the elements were not kind to us this season. I think every team would have spent more time sheltering in the tower than they expected in September, due to consistent rain and wind. We were all amazed to see the appearance of the South Bribie bar in the wash up of Cyclone Seth in January. The resulting changes in shifting sand bars and water flow in and out of Pumicestone Passage is undoubtedly having a significant impact on the prevailing conditions at Kings Beach, and even more so at Happy Valley. At times this brought joy to the boardriders among us, however from a lifesaving perspective it has also resulted in an unusual number of swimmers and craft users who required our assistance.

The rescue skills, teamwork, courage and commitment of many of our members were put to great use with numerous significant incidents presenting to our members in very challenging conditions. Some of these were high profile with media coverage and award nominations following. Others became our new 'business as usual'. Together we met every challenge, then backed up ready for the next. I can confirm that 6 of our members will soon be recognised with the SLSA National Rescue Medal for their response to a life-threatening injury near the boat ramp in January. Congratulations to Thomas Basford, Maggie Princehorn, Sam Princehorn, James Creedy, Ken McGrath and Dan McShea for this outstanding achievement. Your efforts not only saved a man's life, but also prevented him from sustaining catastrophic injuries. We also have a number of other members who have been nominated for SLSQ Lifesaving Excellence Awards, and we are optimistic these nominations will be successful. Anecdotally, I have spoken with many other members about rescues or near misses across most patrol teams on most weekends. In every instance, it is clear that we performed with a level of care and skill that should make us all proud of our fellow members. As a result of each of you giving your time so generously, I'm very happy to report another year fatality-free on Kings Beach. Well done to you all.

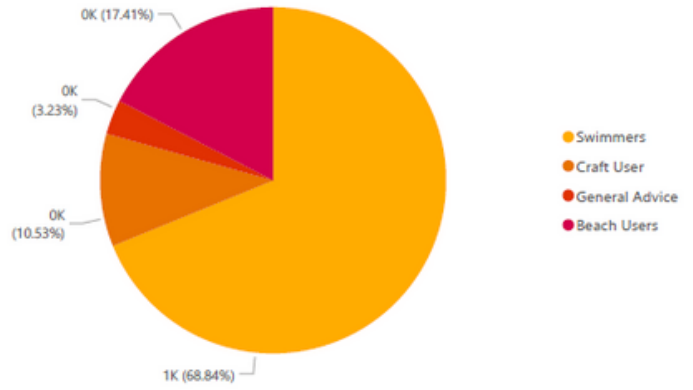

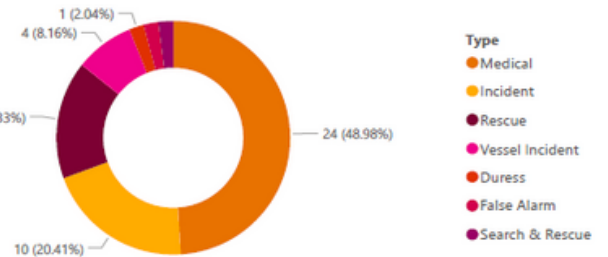

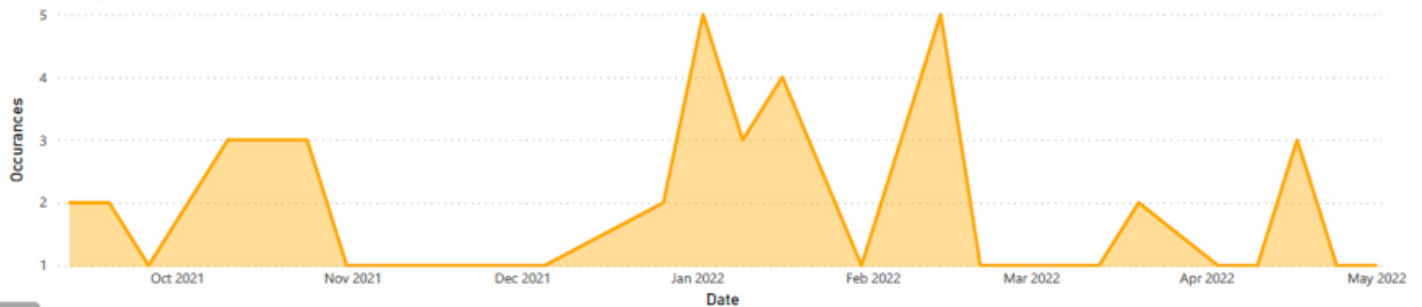

Incidents by Date



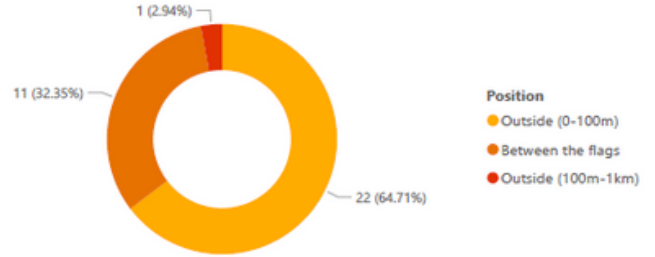

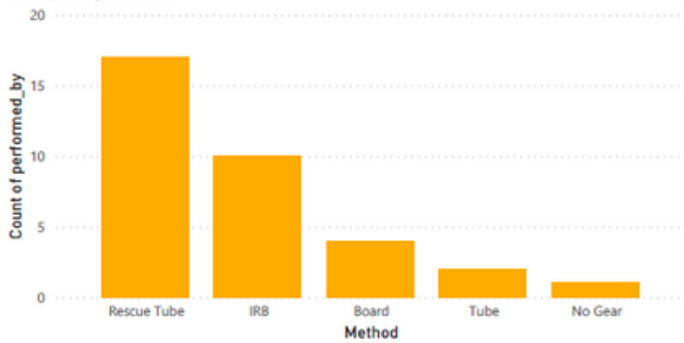

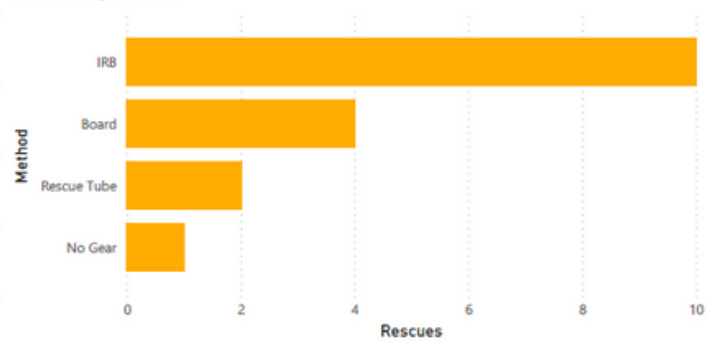
Position Rescued

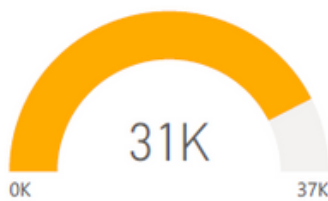

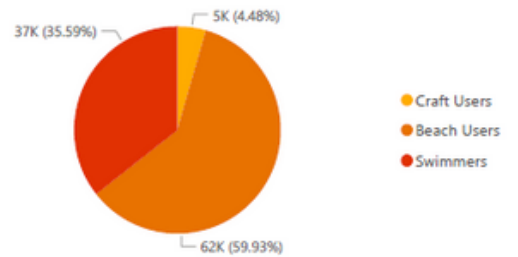

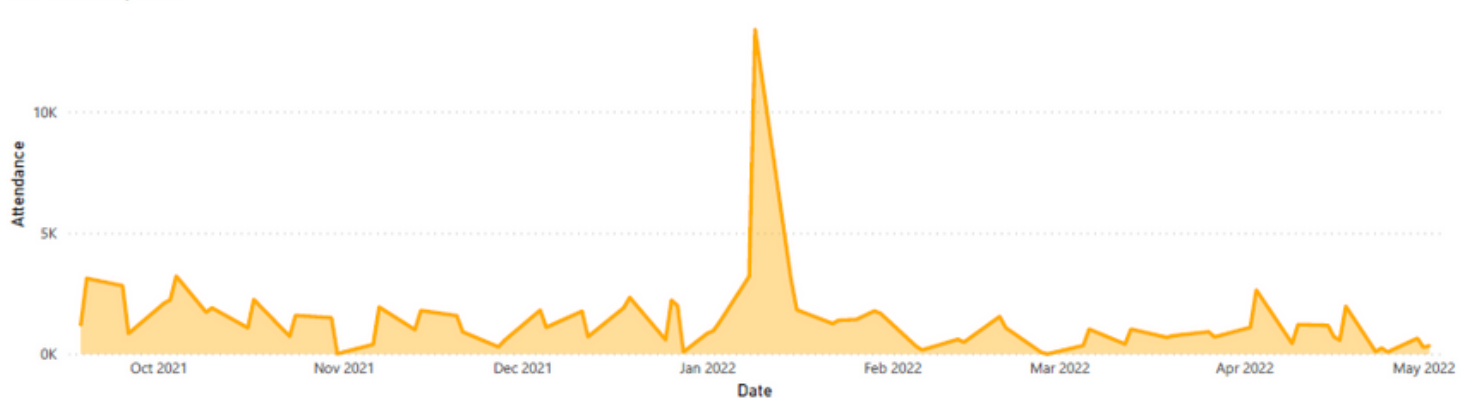
Swimmers Between The Flags

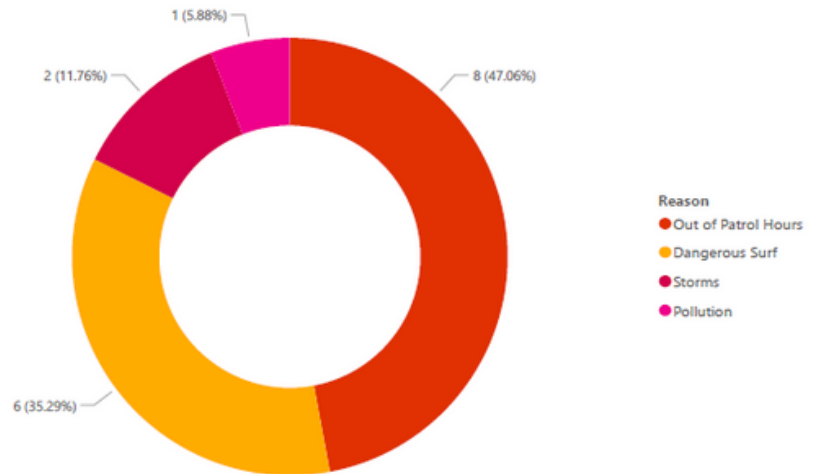

CHIEF TRAINING OFFICER REPORT

I would like to express my gratitude to everyone who assisted with the delivery of training or assessment this year, from the trainers and assessors to those who volunteered as water safety, content experts, helped with uniform allocations and welcomed new members to their patrols. This assistance is greatly appreciated and allows the small but dedicated education group within the club to continue to deliver courses to help our club grow in numbers and skill.

COVID changes and guidelines continue to play a part in the delivery of training and assessment, patience of club members was appreciated as we worked through those rule changes and updates.

We were able to run three larger bronze medallion and SRC programs this season with strong numbers going through each program. Unfortunately, none of these programs were able to be 'live in camps' due to the COVID restrictions. In total we had 36 bronze medallions awarded this season, as well as 40 SRCs. These numbers are an increase on last season and show the continued growth of the club.

In the time before the season started changes were implemented to the content of the first aid and ART awards. Special thanks to Liz Dawes and Bruce Edwards as the ECT facilitators who delivered those courses.

We confined to upskill members in IRB training with members obtaining their IRB crew person awards. Unfortunately, the poor weather and flooding this season meant the cancellation of the IRB Drivers course this season. The training team will be on track to deliver that course next season.

Also, to Liz Dawes for her significant support in training and delivering courses. SURF SPORTS REPORT



The past year has been another big year of growth and development within surf sports. We have been challenged with COVID and poor weather, but we have managed to grow and achieve some amazing results.

The club focuses surf sports on participation and opportunities to train. There have been some great initiatives in the past year including Learn to Ski, Mets Cruisers, the Met 48 and we continue to support coached sessions within the club and with external coaches across a range of disciplines.



Unfortunately, Aussies was moved from Perth to the Gold Coast which was good for us locals to travel but we are planning on building towards Aussies in Perth in 2023. Funds already raised for Perth will be used in 2023 towards costs in taking our team and equipment to Perth. A session will be planned as we commence the new season to plan logistics and gathering initial numbers.

Working with the other areas of the club we have obtained grants for new skis and continue to work with grants for equipment to offer additional training opportunities. Next season we are looking to grow key areas within surf sports providing more opportunities to train, particularly as a whole club. We are also looking at some land-based training equipment to assist the coaches in sessions and provide opportunities when weather is poor.

Key updates across the areas:

Pool Rescue

The club continues to improve in the pool rescue arena, placing 3rd overall at State Championships for the second year in a row, a pretty amazing effort for a club only in its 5th season since re-starting pool rescue.

It was great to see an increased number of Masters competitors join our younger members and increasing number of U17 and U19 members at the State Championships. There were a lot of great individual performances in addition to strong team and relay efforts - including Sophie Hebron in U11 winning 7 medals from 7 events, and James Leigh in U14 being selected in the QLD Cyclones Pool Rescue Team.

Unfortunately, due to Covid the Australian Pool Rescue Championships were first delayed and then ultimately cancelled for the second year in a row. We look forward to our pool rescue competitors being able to compete at the highest level in the coming season.

Surf, Board, Ski and Ironperson

We have had some amazing results this season in the water, we continue to work with Clint Robinson and have grown the number of members training and racing ski's. There are numerous opportunities to train across all levels of the club including sessions at different locations to cater for abilities and training in varied conditions.

State Championships were cancelled due to weather but we had a small group represent the club at Youth Aussies and Open Aussies. Highlights included Gold, Silver and Bronze medals by Daisy Quinn (U15) in 2km Swim, Surf Race and Ironwoman races, a Silver Medal in U17 Female Ski Relay (Eva Ashworth, Maggie Princehorn and Jade Gardiner) and a number of top 10 placings including U17 Female Surf Teams (4th), U17 Female Board Rescue (4th and 8th) and U17 Female Board Relay (7th).

It was really pleasing to see the club have 2 teams make finals in U17 Female Board Rescue and U17 Board Relay, highlighting the depth in that age group and their commitment to training.

Board Riding

Under the ongoing guidance of Chris O'Shea we have again seen our competitor numbers in board riding increase, with more numbers competing at State Championships and for the first time in a while a number of competitors representing the club at Australian Championships, with some excellent team results along the way.

Beach

The beachies have grown and received some amazing results. We welcomed Luke Saunders on board as our new club Beach Coach during the season and also saw the introduction of Andrew Kwintoski and Peter Bell to our coaching ranks.

Some key highlights are 2nd in the QLD Beach Series Overall Pointscore with Jaz Edmonstone (U12), Bailen Noy (U13) and Pipi Barlow (U14) winning Age Champion across the series.

Again we missed State Championships but had a strong group represent the club at Australian Championships, with the highlights being a Bronze medal to Clay Andrews in U15 Male Beach Sprint, a Bronze medal in U15 Male Beach Relay (Clay Andrews, Taione Taka, Lachlan Ray and Millar Gazzard) with a number of other top 10 finishes.

At Open Aussies we saw Kieren Perkins return to competition for the first time in 10 years and win a close Silver in the 2km Open Beach Run, with Sophie Taylor also having an incredible race to win a Bronze Medal in the U17 Female 2km Beach Run.

Masters

It was also pleasing to see increased numbers in Masters competitors in Pool Rescue, Endurance, Beach, Board Riding and the traditional disciplines in the Surf. TREASURER'S REPORT

The start of the season saw most of Australia either in lockdown or isolation.

Our core plan was for a normal season. We also planned for the worst case which fortunately was not required.

Patrols commenced and were more affected by wild weather. Congratulations to all the Patrol Captains and teams for a job very well done. Thank you to Shane Punter who took on Club Captain at short notice you did a great job. Thank you also goes to the Patrols for taking on the raffles at the Supporters Club.

The JAC under the leadership of Brett Magnussen had a successful year with high levels of membership and a full range of activities. The JAC were very active in fund raising. This included the Surf Appeal, Raffles both at the Supporters Club and Kings Beach Tavern. Thank you to Ann Mee for her role in having successful raffles throughout the year.

Emily Hiley and her Surf Appeal team followed on from last year to increase both the cash collection and also the internet collection. A record \$61,096 was raised. As with the previous year the Surf Appeal success underwrote the ongoing costs for the season. Congratulations to Emily Hiley and the Surf Appeal team for financially kickstarting the 2021/22 season.

The major financial challenge we had in this year was funding a team to go to Western Australia to compete in the Aussie titles.

Brendan McDonalds inspirational Nauru paddle raised \$5,044 to start the Surf Sports fundraising. The Board underwrote fund raising by allocated all funds over \$40,000 raised in the Surf Appeal (\$20,196), Members raised \$22,213 from raffles at the KBT and Supporters Club. There was also a Bunnings BBQ, and donations from Members boosted the total.

TREASURER'S REPORT CONT.

Funds raised for Surf Sports totalled \$50,007.21 for the 2022 financial year.

Total spent on Surf Sports was \$82,969.44. This included \$8,135 spent on Subsidy of Aussie Uniforms

The budget for Surf Sports was \$75,000 for the year.

This budget shortfall was \$7,969.44

Taking this additional expenses \$7,969.44 away from total raised \$50,007.21 = \$42,037.77 reserve

Surf Sports will start the 2022/23 season with reserves of \$42,037.77

Congratulations to Aleisha Edwards for taking over from Simon Richards in training our members.

Simon has contributed so much to the Club over the years in this role. Aleisha with the support of many other trainers provided a seamless transition to ensure a high level of training was delivered to our members at a very acceptable cost.

Member Development had some challenges with a couple of camps cancelled. Camp Commando has been re-scheduled so this vital leadership camp can be experienced by our young members. Met's Foundation continues to fund Member Development. Our investment in our young members is showing some returns through leadership shown on Patrol, in competition, and in social events by our young members. Congratulations to Eliza for doing such a great job in this area.

Brent Hiley continued to do a brilliant job of applying for and obtaining \$127,822 in Grant Funding.

Storage Shed \$35,000, Cam Am Defender \$24,885, backwall Clubhouse \$15,370, SLSA \$15,000 Rescue Equipment, Roof Clubhouse \$27,500. Thank you to our building committee who supervised the Storage Shed, Roof Repairs, and back wall repairs.

Brent also oversaw the signing up of sponsors raising a further \$31,745 in Sponsorship.

Our major sponsor was Henzell's Agency. Henzell's Agency generously sponsored us for \$10,000.

McLean Henzell also sponsored us for two training skis and JAC State Uniforms. Other major sponsors were Stockland Aura, Viden, Caloundra Seafood, South Coast Boats, Perkins Plumbing and Tile Solutions.

TREASURER'S REPORT CONT.

The Supporters Club remained our major source of funding. Despite many challenges they were able to maintain their rental payments of \$20,000 per month. They also supported the club through sponsorship of members drinks, and clubhouse operating expenses. We are very grateful for the efforts of the Supporters Club and their Board to allow us to continue to build our reserves.

We have improved our cash reserves by \$98,537 and funded projects of \$196,038 made up of:

New Rescue boards \$9,593, Solar on Clubhouse \$18,568, New Roof on Clubhouse \$51,095. Training Skis \$12,318, Air conditioning and Office Furniture \$7,546, Rowing Machines \$4,500, Training Equipment \$3,429, Cam Am Defender \$25,610, Storage Shed \$48,014, Cubicles Men's showers \$7,548.

Thank you to all who assisted to raise funds and more importantly those who showed restraint in spending. This measured approach to financial management has put our Club in a strong financial position.

FOUNDATION COMMITTEE REPORT

With funds of \$394,935 held on 30th April 2022 the Foundation is approaching \$400,000.

During the year we received \$8,536 in donations and the Club transferred in \$19,800. In return we paid \$8,283 to the Club for Member development.

We are continuing to support the Club through our transfer of the bulk of the funds to offset the Club's Business Loan account. That amount is now \$341,600, having been \$350,000 last year. That amounts to a significant saving of interest for the Club, even at the reduced rates which have prevailed so far this year.

This year the Club Board is looking at ways to enhance the stability of the Foundation through the creation of a Foundation Public Ancillary Fund. An important aspect of this will be a favourable tax ruling which is awaited

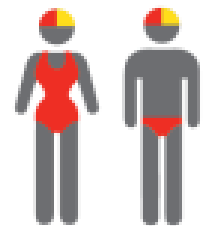

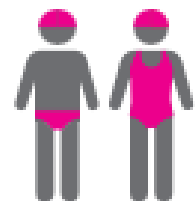

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

General Information

The financial statements cover Metropolitan Caloundra Surf Life Saving Club Inc ("the club") as an individual entity.

Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board and the Australian Charities and Not-for-profits Commission Act 2012. The club is a not-for-profit entity for financial report purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements, except the cash flow information, have been prepared on accrual basis and are based on historical costs, modified where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest Australian dollar.

The financial statements were authorised for issue on *11th* June 2022 by the Board of Management.

Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to confirm changes in presentation for the current financial year.

(a) Income Tax

The Australian Charities and Not-for-profit Commission have endorsed the association as a charitable institution.

No provision for income tax has been raised as the association is exempt from income tax under Section 50-5 of the *Income Tax Assessment Act 1997*.

(b) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the Statement of Financial Position.

(c) Property, Plant and Equipment

Property, plant and equipment are measured on the cost basis or fair value as indicated less where applicable, less depreciation and impairment losses.

Property, plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1(f) for details of impairment).

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the club and the cost of the item can be measured reliably. All other repairs and maintenance are recognised as expenses in profit or loss in the financial period in which they are incurred.

Plant and equipment that have been contributed at no cost or for nominal cost are recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including capitalised leased assets, is depreciated on a diminishing value basis over their estimated useful lives to the club commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of assets are:

Buildings	2.5%
Plant and equipment	10% - 20%
Craft equipment	10% - 20%
Motor vehicles	20%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposal are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit and loss and other comprehensive income.

(d) Leases

At inception, the Club considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition the Club assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Club;
- the Club has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract;
- the Club has the right to direct the use of the identified asset throughout the period of use. The Club assess whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

Measurement and recognition of leases as a lessee

At lease commencement date, the Club recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Club, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Club depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Club also assesses the right-of-use asset for impairment when such indicators exist. At the commencement date, the Club measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Club's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments. When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

(d) Leases (continued)

The Club has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these are recognised as an expense in profit or loss on a straight-line basis over the lease term. On the statement of financial position, right-of-use assets have been included in property, plant and equipment and lease liabilities have been included in trade and other payables.

The Club as a lessor

As a lessor, the Club classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset and classified as an operating lease if it does not.

(e) Financial Instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the association becomes a party to the contractual provisions to the instrument. For financial assets, this is the date that the association commits itself to either the purchase or sale of the asset (i.e. trade date accounting is adopted).

Financial instruments (except for trade receivables) are initially measured at fair value plus transaction costs, except where the instrument is classified "at fair value through profit or loss", in which case transaction costs are expensed to profit or loss immediately. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Trade receivables are initially measured at the transaction price if the trade receivables do not contain significant financing component or if the practical expedient was applied as specified in AASB 15: Revenue from Contracts with Customers.

Classification and Subsequent Measurement of Financial Assets

Financial liabilities

Financial liabilities are subsequently measured at:

- amortised cost; or
- fair value through profit or loss.

A financial liability is measured at fair value through profit or loss if the financial liability is:

- a contingent consideration of an acquirer in a business combination to which AASB 3: Business Combinations applies;
- held for trading; or
- initially designated as at fair value through profit or loss.

All other financial liabilities are subsequently measured at amortised cost using the effective interest method.

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest expense over its profit or loss over the relevant period.

The effective interest rate is the internal rate of return of the financial asset or liability. That is, it is the rate that exactly discounts the estimated future cash flows through the expected life of the instrument to the net carrying amount at initial recognition.

A financial liability is held for trading if it is:

- incurred for the purpose of repurchasing or repaying in the near term;
- part of a portfolio where there is an actual pattern of short-term profit-taking; or
- a derivative financial instrument (except for a derivative that is in a financial guarantee contract or a derivative that is in effective hedging relationships).

Any gains or losses arising on changes in fair value are recognised in profit or loss to the extent that they are not part of a designated hedging relationship.

The change in fair value of the financial liability attributable to changes in the issuer's credit risk is taken to other comprehensive income and is not subsequently reclassified to profit or loss. Instead, it is transferred to retained earnings upon derecognition of the financial liability.

If taking the change in credit risk in other comprehensive income enlarges or creates an accounting mismatch, then these gains or losses should be taken to profit or loss rather than other comprehensive income.

A financial liability cannot be reclassified.

Financial assets are subsequently measured at:

- amortised cost;
- fair value through other comprehensive income; or
- fair value through profit or loss

Measurement is on the basis of two primary criteria:

- the contractual cash flow characteristics of the financial asset; and
- the business model for managing the financial assets.

A financial asset that meets the following conditions is subsequently measured at amortised cost:

- the financial asset is managed solely to collect contractual cash flows; and
- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates.

A financial asset that meets the following conditions is subsequently measured at other comprehensive income:

- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates; and
- the business model for managing the financial asset comprises both contractual cash flows collection and the selling of the financial asset.

By default, all other financial assets that do not meet the measurement conditions of amortised cost and fair value through other comprehensive income are subsequently measured at fair value through profit or loss.

The association initially designates a financial instrument as measured at fair value through profit or loss if:

- it eliminates or significantly reduces a measurement or recognition inconsistency (often referred to as an "accounting mismatch") that would otherwise arise from measuring assets or liabilities or recognising the gains and losses on them on different bases;
- it is in accordance with the documented risk management or investment strategy and information about the groupings is documented appropriately, so the performance of the financial liability that is part of a group of financial liabilities or financial assets can be managed and evaluated consistently on a fair value basis; and
- it is a hybrid contract that contains an embedded derivative that significantly modifies the cash flows otherwise required by the contract.

The initial designation of financial instruments to measure at fair value through profit or loss is a one-time option on initial classification and is irrevocable until the financial asset is derecognised.

Equity Instruments

At initial recognition, as long as the equity instrument is not held for trading or not a contingent consideration recognised by an acquirer in a business combination to which AASB 3 applies, the association made an irrevocable election to measure any subsequent changes in fair value of the equity instruments in other comprehensive income, while the dividend revenue received on underlying equity instruments investment will still be recognised in profit or loss.

Regular way purchases and sales of financial assets are recognised and derecognised at settlement date in accordance with the association's accounting policy.

Derecognition

Derecognition refers to the removal of a previously recognised financial asset or financial liability from the statement of financial position.

Derecognition of financial liabilities

A liability is derecognised when it is extinguished (ie when the obligation in the contract is discharged, cancelled or expires). An exchange of an existing financial liability for a new one with substantially modified terms, or a substantial modification to the terms of a financial liability, is treated as an extinguishment of the existing liability and recognition of a new financial liability.

The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Derecognition of financial assets

A financial asset is derecognised when the holder's contractual rights to its cash flows expires, or the asset is transferred in such a way that all the risks and rewards of ownership are substantially transferred.

All the following criteria need to be satisfied for the derecognition of a financial asset:

- the right to receive cash flows from the asset has expired or been transferred;
- all risk and rewards of ownership of the asset have been substantially transferred; and
- the association no longer controls the asset (ie has no practical ability to make unilateral decision to sell the asset to a third party).

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

On derecognition of a debt instrument classified as fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment revaluation reserve is reclassified to profit or loss.

On derecognition of an investment in equity which the association elected to classify under fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment's revaluation reserve is not reclassified to profit or loss, but is transferred to retained earnings.

(e) Financial Instruments (Continued)

Impairment

The association recognises a loss allowance for expected credit losses on:

- financial assets that are measured at amortised cost or fair value through other comprehensive income;
- lease receivables;
- contract assets (eg amount due from customers under construction contracts);
- loan commitments that are not measured at fair value through profit or loss; and
- financial guarantee contracts that are not measured at fair value through profit or loss.

Loss allowance is not recognised for:

- financial assets measured at fair value through profit or loss; or
- equity instruments measured at fair value through other comprehensive income.

Expected credit losses are the probability-weighted estimate of credit losses over the expected life of a financial instrument. A credit loss is the difference between all contractual cash flows that are due and all cash flows expected to be received, all discounted at the original effective interest rate of the financial instrument.

The association uses the following approaches to impairment, as applicable under AASB 9: Financial Instruments:

- the general approach;
- the simplified approach;
- the purchased or originated credit-impaired approach; and
- low credit risk operational simplification.

General approach

Under the general approach, at each reporting period, the association assesses whether the financial instruments are credit-impaired, and:

- if the credit risk of the financial instrument has increased significantly since initial recognition, the association measures the loss allowance of the financial instruments at an amount equal to the lifetime expected credit losses; and
- if there is no significant increase in credit risk since initial recognition, the association measures the loss allowance for that financial instrument at an amount equal to 12-month expected credit losses.

Simplified approach

The simplified approach does not require tracking of changes in credit risk at every reporting period, but instead requires the recognition of lifetime expected credit loss at all times.

This approach is applicable to:

- trade receivables; and
- lease receivables.

In measuring the expected credit loss, a provision matrix for trade receivables is used taking into consideration various data to get to an expected credit loss (ie diversity of its customer base, appropriate groupings of its historical loss experience, etc).

Purchased or originated credit-impaired approach

For financial assets that are considered to be credit-impaired (not on acquisition or originations), the association measures any change in its lifetime expected credit loss as the difference between the asset's gross carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate. Any adjustment is recognised in profit or loss as an impairment gain or loss.

Evidence of credit impairment includes:

- significant financial difficulty of the issuer or borrower;
- a breach of contract (eg default or past due event);
- a lender has granted to the borrower a concession, due to the borrower's financial difficulty, that the lender would not otherwise consider;
- the likelihood that the borrower will enter bankruptcy or other financial reorganisation; and
- the disappearance of an active market for the financial asset because of financial difficulties.

Low credit risk operational simplification approach

If a financial asset is determined to have low credit risk at the initial reporting date, the association assumes that the credit risk has not increased significantly since initial recognition and, accordingly, can continue to recognise a loss allowance of 12-month expected credit loss.

To make such a determination that the financial asset has low credit risk, the association applies its internal credit risk ratings or other methodologies using a globally comparable definition of low credit risk.

A financial asset is considered to have low credit risk if:

- there is a low risk of default by the borrower;
- the borrower has a strong capacity to meet its contractual cash flow obligations in the near term; and
- adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

A financial asset is not considered to carry low credit risk merely due to existence of collateral, or because a borrower has a lower risk of default than the risk inherent in the financial assets, or relative to the credit risk of the jurisdiction in which it operates.

Recognition of expected credit losses in financial statements

At each reporting date, the association recognises the movement in the loss allowance as an impairment gain or loss in the statement of profit or loss and other comprehensive income.

The carrying amount of financial assets measured at amortised cost includes the loss allowance relating to that asset.

Assets measured at fair value through other comprehensive income are recognised at fair value with changes in fair value recognised in other comprehensive income. The amount in relation to change in credit risk is transferred from other comprehensive income to profit or loss at every reporting period.

For financial assets that are unrecognised (eg loan commitments yet to be drawn, financial guarantees), a provision for loss allowance is created in the statement of financial position to recognise the loss allowance.

(f) Impairment of Assets

At each reporting date, the club reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less cost to sell and value in use, is compared to the asset's carrying value. Any excess of the assets carrying value over its recoverable amount is expensed to the statement of comprehensive income.

Where it is not possible to estimate the recoverable amount of an individual asset, the club estimates the recoverable amount of the cash-generating unit to which the asset belongs.

(g) Employee Provisions

Provision is made for the club's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on corporate bonds with terms to maturity that match the expected timing of cash flows attributable to employee benefits. Contributions are made by the club to employee superannuation funds and are charged as expenses when incurred.

(h) Provisions

Provisions are recognised when the club has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(i) Revenue Recognition

Contributed Assets

The club receives assets from the government and other parties from time to time for nil or nominal consideration in order to further its objectives. These assets are recognised in accordance with the recognition requirements of other applicable accounting standards (for example AASB 9, AASB 16, AASB 116 and AASB 138.)

On initial recognition of an asset, the club recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer).

The club recognises income immediately in profit or loss as the difference between initial carrying amount of the asset and the related amount.

Operating Grants, Donations and Bequests

When the club receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the club: - identifies each performance obligation relating to the grant - recognises a contract liability for its obligations under the agreement

- recognises revenue as it satisfies its performance obligations. Where the contract is not enforceable or does not have sufficiently specific performance obligations, the club:
- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (for example, AASB 9, AASB 16, AASB 116 and AASB 138)
- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

(i) Revenue Recognition (continued)

If a contract liability is recognised as a related amount above, the club recognises income in profit or loss when or as it satisfies its obligations under the contract.

Capital Grant

When the club receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The club recognises income in profit or loss when or as the club satisfies its obligations under the terms of the grant.

Interest Income

Interest income is recognised using the effective interest method.

Revenue from the sale of goods

Revenue from sale of goods comprises revenue earned from sale of goods donated and resale. Sales revenue is recognised when the control of goods passes to the customer.

All revenue is stated net of the amount of goods and services tax (GST) where applicable.

(j) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities, which are recoverable from or payable to the ATO, are presented as operating cash flows included in receipts from customers or payments to suppliers.

(k) Trade and Other Receivables

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from customers for goods sold in the ordinary course of business. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Accounts receivable are initially recognised at fair value and subsequently measured at amortised cost using the effective interest rate method.

(l) Inventories

Inventories are measured at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses.

(m) Trade and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the club during the reporting period which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(n) Critical Accounting Estimates and Judgements

The Board of Management evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the club.

Key Estimates – Impairment

The Board of Management assess impairment at each reporting date by evaluating conditions specific to the club that may lead to the impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Value-in-use calculations performed in assessing recoverable amounts incorporate a number of key estimates.

No impairment has been recognised in respect of the current year.

Performance obligations under AASB 15

To identify a performance obligation under AASB 15, the promise must be sufficiently specific to be able to determine when the obligation is satisfied. Management exercises judgement to determine whether the promise is sufficiently specific by taking into account any conditions specified in the arrangement, explicit or implicit, regarding the promised goods or services. In making this assessment, management includes the nature/ type, cost/ value, quantity and the period of transfer related to the goods or services promised.

(o) Fair Value of Assets and Liabilities

The club measures some of its assets and liabilities at fair value on either a recurring or nonrecurring basis, depending on the requirements of the applicable Accounting Standard.

Fair value is the price the club would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific asset or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data.

(p) Economic Dependence

The Club is dependent upon the ongoing receipt of donations and rental income from Metropolitan Caloundra Surf Life Saving Supporters Club to ensure the ongoing continuance of its operations. At the date of this report, the Board of Management has no reason to believe that this financial support will not continue.

(q) New and Amended Accounting Policies Adopted by the Club
