# PRESIDENT'S REPORT



This year saw Jim Chisholm step down as President mid-season. I wish to acknowledge Jim for his leadership over recent years which has involved transitioning the Club to a sound financial footing whilst implementing numerous improvements and navigating the challenges of the pandemic.

Total Club membership for the season was 854 members including 204 Active members, 316 Junior Activities members, and 271 Associate members. Thank you all for your membership, service and support throughout a very successful season for the Club.

All areas of the Club have been well managed this season, with recognition and celebration of their respective successes entirely appropriate. We should all be very proud of our Club and its achievements this season, the highlights of which are outlined below.

#### **Our Operations Group**

Thank you to our Club Captain, Andrew Richards, for his leadership of the Club's operations, which has been a key component of the Club's success this season. Andrew was effective in each of his capacities, namely, Club Captain, coordination of the Operations Group, coordination of the Friday night raffles, liaison with SLSQ Sunshine Coast Branch and Council on lifesaving matters, and communication with the Board on operational issues.

Lifesaving: Thank you to Andrew, Deputy Club Captain, Shane Punter, our Patrol Captains and their respective teams for your service over the season. This season saw over 150,000 members of the public visit Kings Beach, which with increased visitation to Happy Valley, is now one of the busiest stretches of beach on the Sunshine Coast. This combined with challenging conditions on many weekends during the season led to numerous rescues and preventative actions. Sadly, this season saw some of our members involved in two incidents, one after hours at Kings Beach and the other at Happy Valley, which both involved (public) loss of life. Whilst so very tragic, it was heartening to learn that our members who were in attendance did everything possible in attempting to achieve positive outcomes. Unfortunately, these incidents serve as a sobering reminder relative to our messaging to the community to always swim between the red and yellow.

Our purpose is to save lives with an objective of zero preventable drownings on Kings Beach. Our ability to do so is only possible through the ongoing dedication and commitment of our Patrol Captains and patrol teams. Again, thank you.

Training and Education: Thank you to our Chief Training Officer, Aleisha Edwards, and her team of Trainers and Assessors who have again gone about their business with a minimum of fuss. This is a function that is critical to the Club's sustainability in maintaining and growing our patrolling members' necessary awards and skills. This season saw 18 new SRC's and 30 new Bronzies receive their awards in addition to the huge task of skills maintenance and new awards for existing members. An unforgiving but necessary task!

Member Development: Thank you to our Member Development Officer, Eliza Dreves, and her team who have achieved plenty this season. Engagement and development of our youth continues to be a Club success story which has seen retention of many of our nippers to now being senior active members. This has been possible through the team's energy in coordinating engagement activities through member recognition initiatives, events such as Youth Ball, Camp Commando leadership camp, lifesaving training and education courses and Club BBQ's. If not busy enough, Eliza and her team also coordinate the Club's Annual Dinner, award nominations, and the end of season members' survey!

# **PRESIDENT'S REPORT**

Junior Activities: Thank you to Junior Activities Chairperson, Mel Ray, the Junior Activities Committee, and legion of parent volunteers for a successful nipper season. Our nippers excelled in all areas including lifesaving, education, surf sports, and member development activities. It was great to see a junior carnival back on Kings Beach, an excellent initiative for building our Club profile.

Our nipper program is one of the strongest on the Sunshine Coast and its continued success will underpin the Club's ability to enhance member retention rates and our pipeline of patrolling members.

Surf Sports: Thank you to Surf Sports Officer, Jase Bean, coaches, and volunteers for a successful season which included competing at the Aussies in Perth. Mets had a team of 66 athletes and support personnel contest youth, open, and masters' events resulting in 9 medals and 26 top 10 placegetters. A huge vote of thanks to the Club's Surf Sports team for getting everyone to WA and back safely, and their work during The Aussies week to enable our Mets' athletes to achieve their absolute best, whilst enjoying the experience. Well done team! To our athletes, fantastic effort! We are so proud of how you represented the Club and congratulate you on your individual and team results!

Further congratulations to all athletes and the Surf Sports team for your results and Club representation at all carnivals, in all disciplines contested, across the season.

It has been pleasing to watch our Surf Sports participation grow over the past many seasons. The Club's objective is to retain our youth cohort and grow participation in the Open (U17+) age groups. Similarly, subject to volunteer leadership, providing access to additional Surf Sports disciplines is an ambition moving forward.

#### **Our Committees**

Our standing committees are acknowledged for their contribution during the season. Of special note, thank you to Brent Hiley for his tireless work in securing Grant funding and sponsorship as well as coordinating fundraising efforts for the Aussies trip. Equally, thank you to Emily Hiley and band of volunteers for managing the Mets Surf Appeal resulting in >\$30,000, a fantastic result!

#### **Our Life Members**

Our Life Members' contribution over the season is acknowledged - we are fortunate to have so many Life Members active in the Club passing on their experience. It is with sadness that we acknowledge the passing of Life Member, Joe Irwin over the course of the season, and remember the contributions he made to the Club. Condolences go out to the Irwin family.

#### **Our Assets**

Our Clubhouse, the Pavilion, and the Boathouse are Sunshine Coast Regional Council (Council) assets with community leases in favour of the Club (the Surf Life Saving Club (SLSC)).

Dialogue with the Council is continuing relative to a proposal to redevelop the Boathouse. I hope to provide Members with positive news on this front next season subject to the content of Council's FY24 budget.

# TREASURER'S REPORT



This season has seen us moving away from Covid issues and on to many other challenges.

Congratulation to Club Captain Andrew Richards and the Patrol Captains and teams for a job very well done in patrolling our beach in challenging conditions. The continual changes to the bar and large crowds swimming South of the groyne increased the level of responsibility taken on by our Patrols. A big thank you to all Patrol members.

Thank you also goes to the Patrols for doing the Friday night raffles at the Supporters Club.

The JAC under the leadership of Mel Ray had a successful year with high levels of membership and a full range of activities. The JAC were very active in fund raising. This included the Surf Appeal, raffles both at the Supporters Club and Kings Beach Tavern.

Emily Hiley and her Surf Appeal team followed on from last year to complete the annual collection. Tougher economic conditions with rising interest rates gave us a reality check with the Appeal raising \$33,000. A couple of years ago this would have been met with great joy as anything above \$20,000 was considered a good result. We had budgeted for a lower figure and are thankful for the support shown to our club by the community. Congratulations to Emily and the Surf Appeals team for financially kickstarting the 22/23 season. Emily has been an integral figure of the SOS for several seasons. Thank you, Emily.

One of the major financial challenges this season was funding a team to go to Western Australia to compete in the Aussie titles. Analysis of the cost of sending a team to the Aussies at a very affordable cost to members showed it costing \$38,000 plus nomination fees. A big thank you to Phill Ashworth and Amerro Engineering for organising a truck and container to transport our gear to Perth and back. He not only organised the transport, but he also put many hours and resources into fitting out the container at no cost

to the club.



I need to acknowledge the heavy lifting that Brent Hiley did in organising the accommodation, airfares, member contributions and many other logistics for the trip.

Molly (Jase Bean) organised a boat to be available in Perth, organised his crew and the minibuses used for transport in Perth. Thanks Molly

Thank you to all the members who attended and supervised or contributed in any way to it being a safe and successful trip.

I also need to mention the women's boat crew which self-funded its successful participation in the Ocean Thunder series in Sydney. Well done Molly and crews. A new surf boat next season funded by Aura is a great incentive for success next season. I would also like to thank Molly for organising sponsorship and the gym equipment to allow our members better training facilities.

### **TREASURER'S REPORT**

Funds raised for Surf Sports in Kings Beach Tavern raffles for 2023 was \$9,316.

Members contributed \$11,892 toward the Western Australia Aussie trip cost (they also paid their own airfares, meals and out of pocket expenses).

Total spent on Surf Sports for 2023 was \$136,226.

The budget for Surf Sports was \$75,000 for the year.

The budget shortfall was \$40,018 which was paid from the Surf Sports Reserve Bank account.

Surf Sports will start the 2022/23 season with reserves of \$2,037.77

Congratulations to Aleisha Edwards (Chief Training Officer) for becoming a mum this year. Aleisha was also able to facilitate training at a high level to our members. Aleisha was supported by many other trainers. The training was delivered at a very acceptable cost. Without trainers the club would not be able to function. A very big thank you to all involved in training.

Member Development was again co-ordinated by Eliza Dreves. Met's Foundation continues to fund member development. Our investment in our young members is showing some returns through leadership shown on Patrol, in competition and social events co-ordinated by our young members. Congratulations to Eliza for doing such a great job in this area again.

Brent Hiley continued to do a brilliant job applying for and obtaining Sponsorship and Grant Funding. Major items were, Aura for a new surf boat \$33,408, various other grants totaling \$33,687 for a new IRB and motor, as well as other Patrol and training items. Sponsorship of \$14,300 was received to cover general expenses and the JAC State Uniform. The Supporters Club remained our major source of funding. Despite many challenges they were able to maintain their rental payments of \$20,000 per month. They also supported the club through sponsorship of members drinks and clubhouse operating expenses. We are very grateful for the efforts of the Supporters Club and their Board to allow us to continue to build our reserves.

Due to less grants being available, a return to reality with the SOS collection, and funding the WA Aussie trip the clubs cash reserves did not increase. Importantly we had sufficient in reserves to cover all activities.

The Foundation liquidity improved by \$30,000 and at the time of writing this stands at \$429,093. In a couple of years time given the current donations and Surf Club contributions the Foundation will reach \$500,000.



Thank you to all who assisted to raise funds and more importantly those who showed restraint in spending. This measured approach to financial management has kept our Club in a strong financial position despite higher expenses and lower income. We will need to be very vigilant to ensure this strong financial position is maintained into the future.

### TREASURER'S REPORT

On a sad note, Jim Chisholm resigned as President following the loss of his wife Laurel. Our condolences to you Jim and your family. Thank you, Jim, for all the assistance and support you have given me. Your leadership has resulted in the Club being in a strong position to allow the Club to provide Life Saving services to the Caloundra Community and Surf Sports services to our members. I hope we see Jim continue his involvement in the Club as his experience and expertise is invaluable.

One of the very positive things to occur in the last year is the role of the Operational Group led by Andrew Richards. The Operational Group now meets regularly and reviews Club Operations and provides recommendations to the board. This leads to a higher level of involvement by more members, better transparency of decisions, and therefore better decisions by the Board.

Thank you goes to Kay Blokkeerus and Kate Coles for their support in administering income and expenses of the club. There is a lot of paperwork required to run a club. Thank you, Kay and Kate.

Brett Magnussen became our new President in the new year. Most of the members will know Brett as he has many years' experience with Mets. Brett has a strong administrative and business background. Welcome to being our President Brett.

A special thank you to my wife Lynda for her support to allow me to be part of Mets.

### FOUNDATION REPORT

The value of the Foundation has grown from \$394,935 on 1/5/2022 to \$429,093 in May 2023.

Contributions to this growth were:

- Transfers from the SLSC \$25,200
- Donations from Public \$8,616
- Payment by SLSC for interest saved due to offset \$12,892

The Foundation supported the Surf Club by paying for Youth Member Development of \$12,500

\$90,000 was put into a term deposit in November 2022 earning 3.35%, another \$40,000 will be placed into term deposit to earn more interest.

As interest currently will earn around 4% to provide sufficient income to pay for Youth Member Development

Donations from the public and contributions from SLSC will see the Foundation grow by approximately \$30,000 p.a.

The Foundation is growing at a rate of 7% per annum. A target of \$500,00 will be reached in 2.3 years.

# GRANTS, SPONSORSHIP & FUNDRAISING



It was a bumper year for the Club this year on all fronts as the team built on last year's hard work. It was a fantastic, consistent effort by all which provided much needed funds as the club continues to grow and expand its community offerings.

The years fundraising kicked off with a bang when the club came together to "shake the tin" as part of our annual SOS appeal. Whilst we didn't rival the previous 2 years we still raised over \$30,000 and maintained our spot as Number 1 across the country. There were many fantastic contributions but hats off to Emily Hiley who was the frontperson pulling the whole thing together.

In the uniform shop led by Mel and David Ray, and nipper canteen led by the Lee family (welcome back), Mel and David Ray and Michelle Peters, it was all hands to the pump with the huge number of nippers this year. Due to their hard work, and those that leant a hand each week, we had another great financial contribution from these essential club outlets.

Pleasingly, the weekly raffles have become a muchloved fixture at the Supporters Club and KBT. Massive thank you to the Mets on Kings team and all those who volunteered every week to make these raffles happen. Special thanks also to Adam and the crew at Pinnell's Gourmet Meats who provided all the meat free of charge for both raffles. Through the two raffles we were able to raise much needed funds for surf life saving and surf sports.





Possibly the most significant event in fundraising over the past few years was the Aussies in Perth (March 23rd to April 4th). Thanks to the efforts of many hardworking volunteers, undertaking a range of fundraising activities over several years, the club subsidised the largest Mets team ever to make the journey west. With a club subsidy of over \$50,000 we supported 66 competitors, coaches, officials, IRB crew and chaperones to attend and compete in one our most successful Aussies to date. Well done and thank you to all of those who made a contribution.

# GRANTS, SPONSORSHIP & FUNDRAISING

A couple of highlights include a new surf boat and oars funded by the Stockland Aura Community Fund (\$34,000) and support from the QLD Government through the Gambling Benefit Fund Grant to install 240v power at the shed (\$18,000). In total this year the club received over \$98,000 in Grant funding. This year's grants combined with last years grants have helped the club achieve some major infrastructure goals and maintain our essential lifesaving services.

Whilst the Fundraising and Grant success was brilliant it was complimented by another strong, consistent sponsorship result. This year we welcomed a number of new sponsors and welcomed back ALL of our previous sponsors who continue to support the club. All told, we raised over \$50,000 for the year which was a huge effort and symbolic of the overwhelming generosity of our sponsors.



# LIFESAVING CLUB CAPTAIN REPORT



The 2022/23 season began with no Club Captain appointed at the AGM. This was a concern since the Club Captain is one of the most important positions in the club, being chair of the Operations Group Committee and responsible for the provision of patrols on Kings Beach. A phone call received in July asking if I would be prepared to take on the Club Captain position had me reconsidering my life saving plans for the season. Thirty years after last being Club Captain, and after some careful consideration, I was willing to take on the position again.

Thirty years is a long time. In 1993 there was little or no internet, on-one used email, very few people had mobile phones, no Facebook groups (No Facebook period), and the club's biggest expense would have been postage. Club Captain was a very hands-on position – being at the club most weekends and being involved in most thigs happening at the club.

Nowadays things are very different and allow a more hands off approach to operational leadership. The clubs successes are only possible because of the hard work and effort by every member of the club.

#### Patrols

Well done and thank you to all active members who patrolled Kings Beach this year; and the families and others who supported our active Bronze and SRC members in keeping Kings Beach a safe place to swim. With over 150,000 beach visitations, it was certainly a busy season and with the ever-changing conditions at Happy Valley and the new Caloundra Bar, our patrols were kept on their toes.

There are details of Patrol Hours elsewhere in this report, but quite a few members this season went above and beyond their normal patrol obligations and completed some extraordinary hours on the beach this season – well done and thank you.

Some of our patrol statistics were higher this season, and this may be indicative of the increased beach visitation and improved weather this season, as well as the transition out of Covid restrictions and lockdowns. This season the club recorded 35 rescues, 29 Major First Aid cases, 434 Minor First Aid cases ad 2374 Preventative Actions. A more detailed breakdown of Patrol Statistics is available in this report.

Tragically, the club also experienced several drownings this season within our area of operations. In late January the Sea Turtles patrol responded to Happy Valley/Bulcock Beach to assist with resuscitation efforts on a young woman who had been pulled from the surf. Despite the best efforts of lifesavers, bystanders and QAS Paramedics the resuscitation was unsuccessful. The operational debrief showed that the patrol performed exceptionally well in responding to the incident, whilst maintain a functioning patrol on Kings Beach.

Several weeks later our members were involved in a midweek after-hours incident when a swimmer was pulled from the surf adjacent to the Kings Beach pool. Once again, despite the best efforts of lifesavers and QAS Paramedics, the resuscitation was unsuccessful.

Whilst tragic, both these incidents gave the club an opportunity to gain an insight into SLSQ's Peer Support and counselling processes, and I believe these are very beneficial in response to critical incidents. There is also an opportunity for the club to leverage of these services and put in place some of its own processes for when critical incidents occur in the future.


### LIFESAVING CLUB CAPTAIN REPORT

### LIFESAVING CLUB CAPTAIN REPORT

#### **Challenges and Opportunities**

Whilst reflecting on the past season, it also provides an opportunity to look to the future, and how to best to position ourselves to meet new challenges.

The most obvious challenge we face in the near future is the ever-changing conditions at Happy Valley and the northern tip of Bribie. With the old Caloundra Bar nearly completely blocked, we will see increased visitation in that area as the sand accumulation provides a larger beach area. With unstable surf conditions there will be increased need for lifesaving coverage of this area. Even so, we have to be mindful that our primary area of patrolling is Kings Beach and any additional coverage outside of this area will be dependent on available resources. There are opportunities to embrace new technologies such as patrol-based drones for surveillance, as well as patrol wave runners for rapid response and patrolling. Over the Easter period this season, SLSQ lifeguards provided surveillance patrols at Happy Valley. Early statistics showed they were extremely busy, and this will provide impetus for expanded services in the future. The Operations Group and Board will address some of these issues over the next few seasons.


Another issue we faced this season was the availability of Radio supplies and replacements. Communications is essential in any emergency service operation, and this year I acknowledge our club radio were sometimes lacking due to the inability to acquire replacement batteries and chargers. This will not be an issue next season as the Queensland Government and SLSQ will transition patrols to the Government Wireless Network (GWN) radio system. This will see SLSQ fund, resource and maintain a completely new radio system.

As with any volunteer organisation, it is important that we are continually developing our members and ensure we have members ready to fill our leadership roles. In the coming seasons the club needs to focus on ensuring we have members developing their skills as patrol leaders, but also being exposed to the operations of the club's committees so they are willing and able to step up into committee positions. I believe Mets has some of the best members in the organisation and I look forward to working with the Board and Operations Group Committee to formulate plans to provide development opportunities for all our members.


Once again, I would like to thank every member of the club for their efforts over the season. It is the members who make Mets great! See you all on the beach next season.







# **TRAINING & EDUCATION** CHIEF TRAINING OFFICER REPORT

In my second season in the role as Chief Training Officer (CTO), my personal life had some significant life changes after commencing maternity leave and then welcoming my son Sebastian in December.

Even more so this year, I would like to express my gratitude to everyone who assisted with the delivery of training or assessment this year, from the trainers and assessors to those who volunteered as water safety, content experts, helped with uniform allocations and welcomed new members to their patrols. I would not have been able to act in the role without that assistance and support.

Furthermore, I am grateful for the dedication of the small group of trainers and assessors within the club who continued to deliver courses to help our club grow in numbers and skills. Our trainers and assessors also attended numerous skills maintenance days to process proficiencies for all active and patrolling members.

Training returned to pre COVID-19 conditions which included the return of resuscitation breathing training. Whilst it is fantastic to see a lessening of restrictions on the way training is conducted, this produced a new challenge in increased equipment cleaning practices and hygiene practices which needed to be implemented. We were able to run three larger bronze medallion and SRC programs this season with strong numbers going through each program. Unfortunately, none of these programs were able to be 'live in camps' due to the COVID restrictions. In total we had 30 bronze medallions awarded this season, as well as 18 SRCs, adding to the strength and depth of the patrol roster.

Thank you to all the volunteer water safety and content experts who assisted during these programs.

We continued to upskill members in IRB training with 5 members obtaining their IRB crew person awards and 4 members obtaining their IRB Driver awards.

I would like to extend a sincere thank you to Simon Richards and to Liz Dawes for their significant support in training and delivering courses and assisting me in the role. Lastly to my husband Adam, who makes no complaint about the numerous hours spent at the beach or at the computer working in this role and my son Sebastian who has already attended two bronze courses in his short life.



### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

### **General Information**

The financial statements cover Metropolitan Caloundra Surf Life Saving Club Inc ("the club") as an individual entity.

### **Basis of Preparation**

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Simplified Disclosures of the Australian Accounting Standards Board and the Australian Charities and Not-for-profits Commission Act 2012. The club is a not-for-profit entity for financial report purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements, except the cash flow information, have been prepared on accrual basis and are based on historical costs, modified where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest Australian dollar.

The financial statements were authorised for issue on 3 June 2023 by the Board of Management.

### **Comparative Figures**

When required by Accounting Standards, comparative figures have been adjusted to confirm changes in presentation for the current financial year.

### (a) Income Tax

The Australian Charities and Not-for-profit Commission have endorsed the association as a charitable institution.

No provision for income tax has been raised as the association is exempt from income tax under Section 50-5 of the Income Tax Assessment Act 1997.

### (b) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the Statement of Financial Position.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### (c) Property, Plant and Equipment

Property, plant and equipment are measured on the cost basis or fair value as indicated less where applicable, less depreciation and impairment losses.

Property, plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1(f) for details of impairment).

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the club and the cost of the item can be measured reliably. All other repairs and maintenance are recognised as expenses in profit or loss in the financial period in which they are incurred.

Plant and equipment that have been contributed at no cost or for nominal cost are recognised at the fair value of the asset at the date it is acquired.

#### Depreciation

The depreciable amount of all fixed assets including capitalised leased assets, is depreciated on a diminishing value basis over their estimated useful lives to the club commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of assets are:

Class of Fixed Asset	Depreciation Rate
Buildings	2.5%
Buildings improvements	5-20%
Plant and equipment	10% - 20%
Office, furniture and equipment	10% - 20%
Craft equipment	10%-20%
Motor vehicles	20%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposal are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit and loss and other comprehensive income.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### (d) Leases

At inception, the Club considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition the Club assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Club;
- the Club has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract;
- the Club has the right to direct the use of the identified asset throughout the period of
  use. The Club assess whether it has the right to direct 'how and for what purpose' the
  asset is used throughout the period of use.

Measurement and recognition of leases as a lessee

At lease commencement date, the Club recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Club, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Club depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Club also assesses the right-of-use asset for impairment when such indicators exist. At the commencement date, the Club measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Club's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments. When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

## (d) Leases (continued)

The Club has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these are recognised as an expense in profit or loss on a straightline basis over the lease term. On the statement of financial position, right-of-use assets have been included in property, plant and equipment and lease liabilities have been included in trade and other payables.

## The Club as a lessor

As a lessor, the Club classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset and classified as an operating lease if it does not.

## (e) Financial Instruments

## Initial recognition and measurement

Financial assets and financial liabilities are recognised when the association becomes a party to the contractual provisions to the instrument. For financial assets, this is the date that the association commits itself to either the purchase or sale of the asset (ie trade date accounting is adopted).

Financial instruments (except for trade receivables) are initially measured at fair value plus transaction costs, except where the instrument is classified "at fair value through profit or loss", in which case transaction costs are expensed to profit or loss immediately. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Trade receivables are initially measured at the transaction price if the trade receivables do not contain significant financing component or if the practical expedient was applied as specified in AASB 15: Revenue from Contracts with Customers.

## Classification and Subsequent Measurement of Financial Assets

## **Financial liabilities**

Financial liabilities are subsequently measured at:

- amortised cost; or
- fair value through profit or loss.

A financial liability is measured at fair value through profit or loss if the financial liability is:

- a contingent consideration of an acquirer in a business combination to which AASB 3: Business Combinations applies;
- held for trading; or
- initially designated as at fair value through profit or loss.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

## (e) Financial Instruments (Continued)

All other financial liabilities are subsequently measured at amortised cost using the effective interest method.

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest expense over in profit or loss over the relevant period.

The effective interest rate is the internal rate of return of the financial asset or liability. That is, it is the rate that exactly discounts the estimated future cash flows through the expected life of the instrument to the net carrying amount at initial recognition.

A financial liability is held for trading if it is:

- incurred for the purpose of repurchasing or repaying in the near term;
- part of a portfolio where there is an actual pattern of short-term profit-taking; or
- a derivative financial instrument (except for a derivative that is in a financial guarantee contract or a derivative that is in effective hedging relationships).

Any gains or losses arising on changes in fair value are recognised in profit or loss to the extent that they are not part of a designated hedging relationship.

The change in fair value of the financial liability attributable to changes in the issuer's credit risk is taken to other comprehensive income and is not subsequently reclassified to profit or loss. Instead, it is transferred to retained earnings upon derecognition of the financial liability.

If taking the change in credit risk in other comprehensive income enlarges or creates an accounting mismatch, then these gains or losses should be taken to profit or loss rather than other comprehensive income.

A financial liability cannot be reclassified.

## **Financial asset**

Financial assets are subsequently measured at:

- amortised cost;
- fair value through other comprehensive income; or
- fair value through profit or loss

Measurement is on the basis of two primary criteria:

- the contractual cash flow characteristics of the financial asset; and
- the business model for managing the financial assets.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

## (e) Financial Instruments (Continued)

A financial asset that meets the following conditions is subsequently measured at amortised cost:

- the financial asset is managed solely to collect contractual cash flows; and
- the contractual terms within the financial asset give rise to cash flows that are solely
  payments of principal and interest on the principal amount outstanding on specified
  dates.

A financial asset that meets the following conditions is subsequently measured at other comprehensive income:

- the contractual terms within the financial asset give rise to cash flows that are solely
  payments of principal and interest on the principal amount outstanding on specified
  dates; and
- the business model for managing the financial asset comprises both contractual cash flows collection and the selling of the financial asset.

By default, all other financial assets that do not meet the measurement conditions of amortised cost and fair value through other comprehensive income are subsequently measured at fair value through profit or loss.

The association initially designates a financial instrument as measured at fair value through profit or loss if:

- it eliminates or significantly reduces a measurement or recognition inconsistency (often referred to as an "accounting mismatch") that would otherwise arise from measuring assets or liabilities or recognising the gains and losses on them on different bases;
- it is in accordance with the documented risk management or investment strategy and information about the groupings is documented appropriately, so the performance of the financial liability that is part of a group of financial liabilities or financial assets can be managed and evaluated consistently on a fair value basis; and
- it is a hybrid contract that contains an embedded derivative that significantly modifies the cash flows otherwise required by the contract.

The initial designation of financial instruments to measure at fair value through profit or loss is a one-time option on initial classification and is irrevocable until the financial asset is derecognised.

## Equity instruments

At initial recognition, as long as the equity instrument is not held for trading or not a contingent consideration recognised by an acquirer in a business combination to which AASB 3 applies, the association made an irrevocable election to measure any subsequent changes in fair value of the equity instruments in other comprehensive income, while the dividend revenue received on underlying equity instruments investment will still be recognised in profit or loss.

## (e) Financial Instruments (Continued)

Regular way purchases and sales of financial assets are recognised and derecognised at settlement date in accordance with the association's accounting policy.

#### Derecognition

Derecognition refers to the removal of a previously recognised financial asset or financial liability from the statement of financial position.

Derecognition of financial liabilities

A liability is derecognised when it is extinguished (ie when the obligation in the contract is discharged, cancelled or expires). An exchange of an existing financial liability for a new one with substantially modified terms, or a substantial modification to the terms of a financial liability, is treated as an extinguishment of the existing liability and recognition of a new financial liability.

The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Derecognition of financial assets

A financial asset is derecognised when the holder's contractual rights to its cash flows expires, or the asset is transferred in such a way that all the risks and rewards of ownership are substantially transferred.

All the following criteria need to be satisfied for the derecognition of a financial asset:

- the right to receive cash flows from the asset has expired or been transferred;
- all risk and rewards of ownership of the asset have been substantially transferred; and
- the association no longer controls the asset (ie has no practical ability to make unilateral decision to sell the asset to a third party).

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

On derecognition of a debt instrument classified as fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment revaluation reserve is reclassified to profit or loss.

On derecognition of an investment in equity which the association elected to classify under fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment's revaluation reserve is not reclassified to profit or loss, but is transferred to retained earnings.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

## (e) Financial Instruments (Continued)

#### Impairment

The association recognises a loss allowance for expected credit losses on:

- financial assets that are measured at amortised cost or fair value through other comprehensive income;
- lease receivables;
- contract assets (eg amount due from customers under construction contracts);
- loan commitments that are not measured at fair value through profit or loss; and
- financial guarantee contracts that are not measured at fair value through profit or loss.

Loss allowance is not recognised for:

- financial assets measured at fair value through profit or loss; or
- equity instruments measured at fair value through other comprehensive income.

Expected credit losses are the probability-weighted estimate of credit losses over the expected life of a financial instrument. A credit loss is the difference between all contractual cash flows that are due and all cash flows expected to be received, all discounted at the original effective interest rate of the financial instrument.

The association uses the following approaches to impairment, as applicable under AASB 9: Financial Instruments:

- the general approach;
- the simplified approach;
- the purchased or originated credit-impaired approach; and
- low credit risk operational simplification.

#### General approach

Under the general approach, at each reporting period, the association assesses whether the financial instruments are credit-impaired, and:

 if the credit risk of the financial instrument has increased significantly since initial recognition, the association measures the loss allowance of the financial instruments at an amount equal to the lifetime expected credit losses; and

 if there is no significant increase in credit risk since initial recognition, the association measures the loss allowance for that financial instrument at an amount equal to 12-month expected credit losses.

## Simplified approach

The simplified approach does not require tracking of changes in credit risk at every reporting period, but instead requires the recognition of lifetime expected credit loss at all times.

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### (e) Financial Instruments (Continued)

This approach is applicable to:

- trade receivables; and
- lease receivables.

In measuring the expected credit loss, a provision matrix for trade receivables is used taking into consideration various data to get to an expected credit loss (ie diversity of its customer base, appropriate groupings of its historical loss experience, etc).

Purchased or originated credit-impaired approach

For financial assets that are considered to be credit-impaired (not on acquisition or originations), the association measures any change in its lifetime expected credit loss as the difference between the asset's gross carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate. Any adjustment is recognised in profit or loss as an impairment gain or loss.

Evidence of credit impairment includes:

- significant financial difficulty of the issuer or borrower;
- a breach of contract (eg default or past due event);
- a lender has granted to the borrower a concession, due to the borrower's financial difficulty, that the lender would not otherwise consider;
- the likelihood that the borrower will enter bankruptcy or other financial reorganisation; and
- the disappearance of an active market for the financial asset because of financial difficulties.

Low credit risk operational simplification approach

If a financial asset is determined to have low credit risk at the initial reporting date, the association assumes that the credit risk has not increased significantly since initial recognition and, accordingly, can continue to recognise a loss allowance of 12-month expected credit loss.

To make such a determination that the financial asset has low credit risk, the association applies its internal credit risk ratings or other methodologies using a globally comparable definition of low credit risk.

A financial asset is considered to have low credit risk if:

- there is a low risk of default by the borrower;
- the borrower has a strong capacity to meet its contractual cash flow obligations in the near term; and
- adverse changes in economic and business conditions in the longer term may, but will
  not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow
  obligations.

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

## (e) Financial Instruments (Continued)

A financial asset is not considered to carry low credit risk merely due to existence of collateral, or because a borrower has a lower risk of default than the risk inherent in the financial assets, or relative to the credit risk of the jurisdiction in which it operates.

## Recognition of expected credit losses in financial statements

At each reporting date, the association recognises the movement in the loss allowance as an impairment gain or loss in the statement of profit or loss and other comprehensive income.

The carrying amount of financial assets measured at amortised cost includes the loss allowance relating to that asset.

Assets measured at fair value through other comprehensive income are recognised at fair value with changes in fair value recognised in other comprehensive income. The amount in relation to change in credit risk is transferred from other comprehensive income to profit or loss at every reporting period.

For financial assets that are unrecognised (eg loan commitments yet to be drawn, financial guarantees), a provision for loss allowance is created in the statement of financial position to recognise the loss allowance.

## (f) Impairment of Assets

At each reporting date, the club reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less cost to sell and value in use, is compared to the asset's carrying value. Any excess of the assets carrying value over its recoverable amount is expensed to the statement of comprehensive income.

Where it is not possible to estimate the recoverable amount of an individual asset, the club estimates the recoverable amount of the cash-generating unit to which the asset belongs.

## (g) Employee Provisions

Provision is made for the club's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on corporate bonds with terms to maturity that match the expected timing of cash flows attributable to employee benefits. Contributions are made by the club to employee superannuation funds and are charged as expenses when incurred.

## (h) Provisions

Provisions are recognised when the club has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

## (i) Revenue Recognition

#### Contributed Assets

The club receives assets from the government and other parties from time to time for nil or nominal consideration in order to further its objectives. These assets are recognised in accordance with the recognition requirements of other applicable accounting standards (for example AASB 9, AASB 16, AASB 116 and AASB 138.)

On initial recognition of an asset, the club recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer).

The club recognises income immediately in profit or loss as the difference between initial carrying amount of the asset and the related amount.

## Operating Grants, Donations and Bequests

When the club receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the club: - identifies each performance obligation relating to the grant - recognises a contract liability for its obligations under the agreement

- recognises revenue as it satisfies its performance obligations. Where the contract is not enforceable or does not have sufficiently specific performance obligations, the club:
- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (for example, AASB 9. AASB 16, AASB 116 and AASB 138)
- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

## (i) Revenue Recognition (continued)

If a contract liability is recognised as a related amount above, the club recognises income in profit or loss when or as it satisfies its obligations under the contract.

## Capital Grant

When the club receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The club recognises income in profit or loss when or as the club satisfies its obligations under the terms of the grant.

#### Interest Income

Interest income is recognised using the effective interest method.

#### Revenue from the sale of goods

Revenue from sale of goods comprises revenue earned from sale of goods donated and resale. Sales revenue is recognised when the control of goods passes to the customer.

All revenue is stated net of the amount of goods and services tax (GST) where applicable.

## (j) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities, which are recoverable from or payable to the ATO, are presented as operating cash flows included in receipts from customers or payments to suppliers.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

## (k) Trade and Other Receivables

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from customers for goods sold in the ordinary course of business. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Accounts receivable are initially recognised at fair value and subsequently measured at amortised cost using the effective interest rate method.

#### (I) Inventories

Inventories are measured at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses.

#### (m) Trade and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the club during the reporting period which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

## (n) Critical Accounting Estimates and Judgements

The Board of Management evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the club.

#### Key Estimates - Impairment

The Board of Management assess impairment at each reporting date by evaluating conditions specific to the club that may lead to the impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Value-in-use calculations performed in assessing recoverable amounts incorporate a number of key estimates.

No impairment has been recognised in respect of the current year.

## Performance obligations under AASB 15

To identify a performance obligation under AASB 15, the promise must be sufficiently specific to be able to determine when the obligation is satisfied. Management exercises judgement to determine whether the promise is sufficiently specific by taking into account any conditions specified in the arrangement, explicit or implicit, regarding the promised goods or services. In making this assessment, management includes the nature/ type, cost/ value, quantity and the period of transfer related to the goods or services promised.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2023

## NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

## (o) Fair Value of Assets and Liabilities

The club measures some of its assets and liabilities at fair value on either a recurring or nonrecurring basis, depending on the requirements of the applicable Accounting Standard.

Fair value is the price the club would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific asset or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data.

## (p) Economic Dependence

The Club is dependent upon the ongoing receipt of donations and rental income from Metropolitan Caloundra Surf Life Saving Supporters Club to ensure the ongoing continuance of its operations. At the date of this report, the Board of Management has no reason to believe that this financial support will not continue.

## (q) New and Amended Accounting Policies Adopted by the Club
