

## **MANAGEMENT - President**

At the Annual Dinner and Awards night, I gave a quick synopsis, of what we have achieved in the 2016 – 2017 season. I also presented some of this detail at the Opening of the Deck function for our Supporters club. I will not go into great detail, as many of you were in attendance at these celebrations.

All of this occurred without zero facilities between the flags.

I recognise I state these statistics often but they all reflect the excellent and professionalism you the members bring to our Kings Beach.

#### How has the year transpired?

Within the report, you will see commentary from a number of our officers performing their roles in various areas. I don't intend to touch on them in detail, plus will make the following comments:

Financial

We performed well throughout the year, under the stewardship of Simon Richards.

In the Financial Statements we report a net operating surplus / (deficit) before Depreciation and Rent of (\$5,006) (2016: \$54,812). These items are reported before accounting for a rental donation of \$12,000, capital income of \$29,573 and deck donations of \$174,361. A major factor in the shortfall in 2017 year, being a drop in donation income of approximately \$36,000, (and of which this amount included a large one-off donation

#### **Development of Master Plans**

As reported in 2016 year, the development of master plans was underway, being assisted and financially supported by the Sunshine Coast Regional Council.

These plans were for both the Senior Clubhouse and the Boatshed / Junior / Lifeguard and Patrol building.

The Senior Clubhouse master plan (which included the Supporters Club area), was presented to Council in the later part of last year and was well accepted by the Mayor, Deputy Mayor and the Chief Executive Officer, at a presentation provided to Council by Alan Macklin, President, Supporters Club, and myself.

This is an ongoing process, but we now have a plan we can visually understand and assist us in our planning for the future.

The "Boatshed" master plan was issued, but we now have more work to do with Council, to be able to finalise this plan.

#### Organisational & Management Structure

We introduced a new Constitution in 2015 and also By Laws in 2016.

Via the new Constitution, the concept of the old type boards which operated, were moved to a management type structure, with the Board of Directors responsible for the strategic direction and overall responsibility of the Club.

The day to day operations of the club, is to be provided via an Operations group, that has a direct responsibility and reporting role through to the Board of Directors.

I have attached a copy of the organisation structure that was developed by the Board of Directors in this season. (See attached)

In respect of the Board of Directors and the Operations Group, we had issues throughout the year, in filling certain of the positions.

The position of Secretary was filled for part of the year, and a Director position was vacant throughout the year.

As noted above, in respect of the Operations, group, all positions have now recently been filled, with Matt Richards taking on Surf Sports and Kirsten Phillips, Membership development.

Emily Neal, club captain, has announced due to work commitments, she will not be continuing in the role for 201 – 2018 season. Emily we all thank you for the tremendous effort you have put in.

#### **Going Forwards**

At Board and other meetings, I have sat in discussions as to why we have had trouble filling Board and Operations group positions. The consensus has been that many members are prepared to sit on the side line, but not prepared to commit time and effort. This is a problem that many clubs are facing.

## MANAGEMENT - Treasurer

Not much has changed since my report from last season. Our Club continues to operate on a minimal budget whilst the Supporters Club solidifies its financial position and pays off debt.

Expenses continued to be controlled well in all areas of the Club and we were able to obtain grant funding for a number of capital items such as IRB and motor, rescue boards, equipment for the afterhours emergency response group and radios. Thank you to Nathan Steer for coordinating the majority of our grant applications.

In terms of revenue, positions relating to fundraising and sponsorship have not been filled for a number of years, and as, revenue from these areas continued to stagnate. Having said that, the Nipper BBQ continued to perform well, we had a core group of members regularly selling chocolates and Gary Jones continued to sell SLS Art Union tickets, of which we keep 70 percent of the revenue.

The biggest non-operational aspect of the year was the realisation of the new deck for the club. Over the past few years, we received more than \$170,000 in cash donations, in kind donations and grants to assist in the building of the deck. Extra funds raised enabled us to redo the driveway and the main entrance to the club. The Club will continue to receive donations until all of the available boards have been purchased, which will ensure a small revenue stream in the coming years. The deck had made a significant positive impact to the trading of the Supporters Club and was also used for the SLSC's annual awards of excellence. A big thank you to Glen Forbes, Craig Spender, Jeff Morris and Alan Macklin that managed the concept, fundraising and construction of the deck.

Unfortunately due to an IRB accident I was unable to fulfil the requirements for Club Captain at the beginning of the season and I would like to sincerely thank Nathan Steer for stepping up and assisting during that time. Being organised for the fast approaching season is incredibly important and we were fortunate to begin with a new set of beach report boards and flag stands to keep up our extremely important professional appearance to the public. An iPad along with the new lifesaving operating system, LIMSOC, was introduced and Nathan was able to provide the required information and instructions for its correct use. It may have been frustrating at times when it malfunctioned but overall it has been a fantastic program to assist with our reporting and say a big well done to everyone who has easily adapted to this new system.

Working in a team is also not a trait that goes unnoticed and lifesaving would not function without it, our beautiful Kings Beach would not be patrolled accordingly unless every person raised their hand and said 'I want to help, I want to save lives'. These actions facilitated a fantastic performance of 7,296 preventative actions, 557 first aid treatments and more than 40 aquatic rescues. This is a remarkable effort by all of our members? These actions would not have been possible without the hard work and consistent dedication of our lifesavers that, in total, patrolled a tremendous 8,325 hours in total. A huge thank you to all of those who did volunteer patrols, having more hands to assist makes everybody's job so much easier.

I also need to congratulate the Patrol Captains, Vice Patrol Captains and those who have gained their Silver Medallion in Basic Beach Management for taking on this responsibility and having the proactive mindset and initiative throughout the entire season. Your actions do not go unnoticed and I thank you for supporting me again this season.

For our new members I hope that you've had an unforgettable season and have learnt many new skills and techniques. To our members who continue to develop their lifesaving skills you should be extremely proud of yourselves and proud of how you have contributed to Metropolitan Caloundra SLSC.

We have been fortunate to host multiple multi-cultural groups and teach them about surf awareness and the importance of swimming between the red and yellow flags. This includes a group of over 100 Middle Eastern refugees who had never seen the beach before. It was an amazing experience to be able to watch their faces light up and made me realise how lucky we are to have such beautiful scenery around us. If you know of any groups or schools that would be interested please feel free to contact the surf club and we would be more than happy to assist in these surf talks.

Metropolitan Caloundra SLSC would not function without the generous support of our donors and sponsors. As a volunteering organisation we heavily rely on these contributions to keep King's Beach safe and enjoyable for the public, so I thank you are immensely for your ongoing support.

To our patrolling members and their families, thank you. Thank you for giving up your own time to assist with our incredibly unique organisation. Thank you for putting in the countless hours to develop, improve and exhibit the skills required to save lives.

It has definitely been an amazing experience as club captain for the last two seasons. I have been able to learn and develop quickly and I've enjoyed every second of it. With my new profession I have decided to just focus on my development as a graduate paramedic this year in Brisbane, I will still remain a patrolling member but can no longer apply the responsibility that is required and deserved

## **JUNIOR ACTIVITIES**

The 2016-17 season has been another successful one for Mets Nippers in all aspects including lifesaving, member development, and surf sports. We are fortunate to enjoy an inclusive culture built from our greatest assets; our nippers and our nipper families.

Personally, it has been pleasing to see so many of our kids, who started at green caps, continue to develop their skills as they move through the age groups, and to see their parents become more involved in the Club.

Our membership levels, U6 to U15's (about 240), were maintained from last season, with Junior Activities being a major contributor to the Club's sustainability. Our focus remains building a pipeline of future patrolling members for the Club.

Education, including the provision of basic first aid and practical lifesaving skills, was a key improvement for us this season to enable our nippers fulfil the mandatory education requirements in achieving their awards. Further, many of our U14's received their Surf Rescue Certificates (SRC) and commenced patrols. I was very impressed with the huge quantum of patrol hours and water safety hours racked up by some of our kids. We also had some of our nippers involved in rescues during the season. A memorable moment for me was when a rescue involving two of our U14's, Charlie Punter and Lachie Smith, was recounted to our nipper group at Sunday muster – this seemed to particularly resonate with the younger kids, and resulted in many questions.

Developing leadership skills for our older kids was another improvement we sought to implement this season. When given the opportunity, many of our older kids were great in helping out our younger nippers at Sunday nippers, carnivals, and social events. Many U14 & 15's took the opportunity to attend Camp Commando (SLSQ leadership camp), for which received excellent feedback. Our Nipper Club Captains, Neasan Sheehan and Maddie English, and Vice-Captains, Charlie Punter and Kya Antoniolli, did a great job this season. Good luck to our newly elected Captains for next season; Charlie Punter, Yasmin Richters, and Samara Lee.

Surf Sports was an area of great achievement this season, both in water and beach events, and was testament to the training put in by the kids and the commitment of our coaches. Our levels of participation for the U8 to U10 and U11 to U15 age groups have increased again this season. Of particular note, was the improvement in results achieved by the U11 to U15 group across all carnivals, the results of which are listed in the Annual Report. At the Queensland Youth Surf Life Saving Championships at Hervey Bay, Mets placed 13<sup>th</sup> overall and 3<sup>rd</sup> in the handicap point score — a fantastic team result!

#### Note 1 Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 1981 (Queensland). The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historical costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

#### (a) Income Tax

The Club has received an exemption from income tax in accordance with Section 50-45 of the Income Tax Assessment Act 1997.

#### (b) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation,

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

#### (c) Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

#### (d) Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

#### (e) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

#### (f) Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### (g) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### (h) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

#### (i) Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term. Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

#### (j) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

#### (k) Accounts payable and other payables




